Year 9 Visit to World War One Battlefields: Wednesday 2 July to Friday 4 July 2025

The History Department has organised a trip to visit the battlefields of Northern France and Belgium from Wednesday 2 July to Friday 4 July 2025, which is a fantastic opportunity for students to explore the battlefields and memorials. There is no requirement to have chosen History for GCSE to attend, as it is more closely related to the Year 9 curriculum, and we believe students will benefit from the experience.

We will visit the sites of some of the most important battles of World War One, such as Ypres and Beaumont Hamel, as well as the Tyne Cot Commonwealth Cemetery, Wellington Quarry, Langemark German Cemetery and attend the Last Post Ceremony at the Menin Gate Memorial. The In Flanders Field Museum shows a unique perspective of the war and The Passchendaele Museum offers students the chance to enter the well preserved trenches and underground bunkers.

The cost of the trip is **£365**, which will cover full board accommodation, travel and all entrance fees to museums. Please be aware that there are only **90 places** available on this trip and places will be allocated at the discretion of the school. We regret that, should a place not be offered to your child, no discussion will be entered into as to why that decision has been made. Should more students wish to go than places available, then a reserve list will be set up. If your child does not secure a place on the trip, your deposit will be refunded.

Insurance cover for Covid related issues, through European Study Tours, is also included in the price of the trip. Full details of the guarantee are available on request.

Please note, as per entry requirements in France/Belgium, if you are travelling on a UK passport then your passport must be valid for at least three months after 4 July 2025. Students will also need EITAS travel authorisation to enter the EU from 2025, which parents/carers will need to organise prior to travel.
